

## **2026 Breeding Contract**

This certifies that the mare owner has engaged one service to the VS TOTAL HEARTTHROB (Stallion), APHA #1,058,019, for the 2026 breeding season, from February 9<sup>th</sup> thru June 12<sup>th</sup> unless special arrangements are made in writing as an addendum to this agreement. The Mare Owner/Agent agrees to pay the non-refundable early booking breeding fee of \$700 which includes the booking fee. Any deviation from these terms must be specified in writing as an addendum to this agreement and signed by Stallion Owner and Manager. The balance of the entire breeding fee is due prior to the first shipment of semen. All payments must be made payable to Candice Monsen via venmo, PayPal or check.

Booking – The Mare Owner/Agent must provide the following at time of booking to VS Total Heartthrob:

- Copy of signed Mare Owner/Agent Information Form and Shipment Information Form
  - Rebreeds must fill out a new contract for the current year
- Copy of the Mare's registration papers, with current owner listed. If the Mare is leased a lease agreement must accompany the contract. The owner recorded on the registration certificate will be recorded on the stallion breeding report.
- Booking Fee - This will guarantee you are placed into the Stallion books for that breeding season.
  - This includes all breedings including Auction and Discounted breedings. Any deviation must be specified in writing by either the Stallion Owner and Manager as an addendum to this agreement.

Fees – The following fees are associated with the breeding to VS Total Heartthrob. All fees are non-refundable. All fees must be paid in full and received prior to semen shipments or being placed on the stallion breeding report.

- Booking Fee – \$350
- Breeding Fee – \$350 - The breeding fee is due prior to and not later than 48 hours prior to the 1<sup>st</sup> shipment of semen. This fee and the booking fee above are for the Stallion's services.
- Shipment Fee – This fee covers the cost of collection as well as the freight cost charged by FedEx.
  - Weekday Delivery - \$375
  - Saturday Delivery - \$425
  - Counter-to Counter – Cost may vary please contact the Stallion Manager and Owner for availability and pricing
- Mare Re-breed Fee \$500

Re-Breeds – The Mare will have the right to re-breed under the following conditions.

- If the Mare dies or is deemed unfit to breed during the breeding season, a substitute Mare, approved by the Stallion Owner and Manager, may be bred without any additional breeding fee.

- Live foal guarantee - A live foal is defined as one that stands and nurses without assistance. If foal is born dead, Mare owner agrees to furnish the stallion owner within 7 days a veterinarian's certificate describing the incidence. If the Mare aborts or fails to conceive, she may return during the current breeding season. If it becomes too late to re-breed a Mare during the current season, she may return the following year provided the re-breed fee is paid upon time of signing contract for upcoming year and being placed on the books. All relevant shipping and collection charges will still apply.
- Color guarantee
  - o AQHA only mares - If the foal is born without the qualified markings or color genes/traits to be registered in the American Paint Horse Association in the Regular Registry, the Mare may be rebred, provided a new contract is submitted, the booking fee of \$350 and all relevant collection and shipping charges are paid.
  - o APHA mares - If the foal is born without the qualified markings or color genes/traits to be registered in the American Paint Horse Association in the Regular Registry, the Mare may be rebred, provided a new contract is submitted, a re-breed fee of \$500 and all relevant collection and shipping charges are paid.

The Mare and foal's health and mortality are the full responsibility of the Mare owner before, during and after this breeding. In the event that the stallion dies or becomes unfit for service, this agreement will immediately terminate. Stallion Owner shall have no liability to Mare Owner except notification of its occurrence.

Shipments – Requests for semen shipments are on a first come, first serve basis. Please call early to be placed on the list.

**Semen cannot be guaranteed if notice is given later than 4:00 PM MST the day prior to collection. Although every effort will be made to accommodate Mare Owners/Agents, no semen orders will be filled if notified after 7:00 AM MST on a collection day. Text is preferred way of contact.**

- Notify the Stallion Owner and Manager via phone to request shipments. If there is no answer please leave a voicemail with your name, mare's name, owner's name and requested shipment date. The Stallion Owner and Manager will call you back as soon as possible. Requests via other sources will not be considered notification and will not be responded to.
- **Stallion is collected on Monday, Wednesday and Fridays only. Please arrange to have Mare checked on Sunday, Tuesday and Thursday and schedule shipments accordingly.**
- Semen will not be shipped to Mare without a current credit card number with expiration and CVV code on file or prepaid shipping. Cost of collection and shipment will be charged directly to the credit card on file.
- Shipment Information Form will be provided to the Breeding Facility who manages the shipment. The semen will be shipped following instructions on the Shipment Information Form on file. It is the Mare Owner/Agent's responsibility to ensure that information is accurate and that if changes take place after the form is submitted a new form is provided at least 48 hours prior to ordering shipment.

- The Stallion Owner and Manager as well as the breeding facility are not responsible for the costs arising from shipments lost, damaged, or delayed in transit, or condition of cooled shipped semen upon delivery as there is no control of the shipment once it has left the collection facility.
- Shipments will be sent via Fed-Ex or Airline Counter to Counter service if requested and available. Please note that Counter to Counter is extremely limited due to current flights and may not be guaranteed. If specifics aren't provided, shipment will be sent via next day Fed-Ex following information and instructions from the Shipment Information Form.
- Please note that a signed contract does not guarantee semen will be available on a given day.
- Shipments to Canada will be frozen semen only. Frozen Semen tanks are limited and not guaranteed so ensure to place orders in advance allowing for tank preparation as well as allowing time for permit approval.
